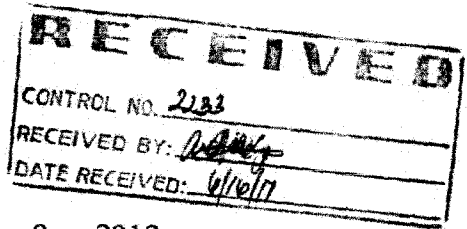
**MACEDA 100: INTERNATIONAL CENTENNIAL SYMPOSIUM OF THE UNIVERSITY
