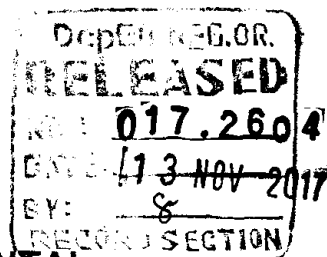



SUBJECT : **TRAINING ON COACHING AND OFFICIATING FOR**
STUDENTS WITH DISABILITIES

DATE : 2 November 2017

1. In its effort to upgrade the coaching competencies of the coaches and technical officials, the Department of Education through the Bureau of Learner Support Services – School Sports Division (BLSS – SSD) will conduct the Training on Coaching and Officiating for Students with Disabilities at The President’s Hotel, Lingayen, Pangasinan from November 20 – 23, 2017.
2. The objective of this training is to capacitate and enhance the knowledge and skills of public school teacher-coaches and technical officials in the science and art of sports coaching and officiating for students with disabilities.
3. There will be twenty-five (25) participants per region, preferably public school teacher-coaches, trainers and technical officials who would best represent their regions. Participants shall be required to submit the following:
 - a) certification from the school principal or from the Division Office that he/she is presently coaching a team and has officiating experiences;
 - b) has at least basic knowledge on handling para-athletes;
 - c) an evidence showing that he/she has at least three (3) years coaching experience; and
 - d) medical certification from a government physician that he/she is medically and physically fit.

Participants who are pregnant are not advised to attend the training.

4. Furthermore, participants are required to bring their personal sports supplies and equipment (eg. whistle), and to wear proper attire during the conduct of the training.
 5. Participants are requested to register at The President's Hotel, Lingayen, Pangasinan on November 19, 2017. The first meal to be served on 19 November will be dinner.
 6. Expenses for this training such as board and lodging, training kit, honoraria of resource speakers, travelling expenses of management staff and resource speakers, office supplies, rental of venues and transport vehicles, sports supplies and equipment and other incidental expenses shall be charged against the Physical Fitness and School Sports Competition funds of the 2017 GAA, subject to usual accounting and auditing rules and regulations. However, travelling expenses of participants shall be charged against local funds.
 7. The Regional Office shall submit their recommended list of participants to the School Sports Division not later than November 7, 2017. The schedule of activities and required number of participants per sport and region are contained in the enclosure.
