

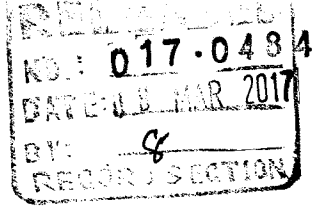


Greetings!
