- Physical refers to acts that inflict bodily harm and which subjects children to perform tasks which are hazardous to their physical well being.
- Sexual refers to the acts that are sexual in nature such as rape, sexcual harassment, sexually demeaning remarks, forcing children to watch

obscene publications or shows, etc. and

- Psychological refers to acts or omissions causing or likely to cause mental or emotional suffering to the child which include intimidation, harassment, stalking, pushing, ridicule, threat or deduction from grade or merit as a form of punishment
- , and repeated verbal abuse.

Relationship to the victim refers to relatives (father, mother, cousin, etc.) or school personnel (teaching and non-teaching staff) No amicable settlement for any acts of child abuse.
