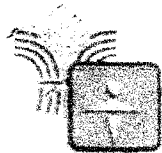

It aims to enhance the knowledge and technical skills of the participants to be more competent in agricultural subjects and widen their technical knowhow so they can effectively impart to their students.

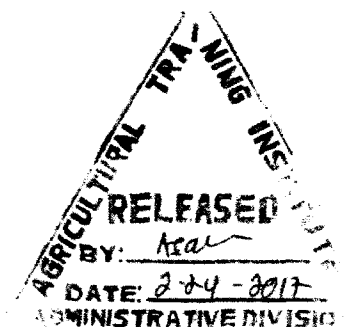
