Subject: **DATA ON SCHOOLS IN ARMED CONFLICT AREAS**

Date: March 20, 2017

1. In line with the memo from the Undersecretary for Administration, all concerned Public Schools District Supervisors through their School Heads are hereby required to submit on or before March 24, 2017, the list of schools in their areas of responsibilities that have been involved in armed conflict situation from 2013 to 2017. The involvement includes either:
 - a. Being within 500 m to 1 kilometer distance from the presence of armed combatants at any given time.
 - b. Having classes suspended as a consequence of nearby armed conflict.
 - c. Having school administrators, teachers, students or service providers prevented from going to schools or performing their school related works.

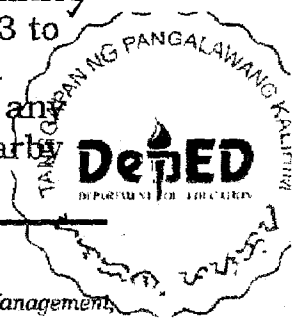
SUBJECT: **DATA ON SCHOOLS IN ARMED CONFLICT AREAS**

DATE: 20 March 2016

On March 28-29, 2017, the Second International Conference on Safe Schools will be held in Buenos Aires, Argentina. The Safe Schools Declaration is an inter-governmental commitment to protect students, teachers, schools, and universities during armed conflicts. States, such as the Philippines, that subscribe to the Declaration made a commitment that includes: improving reporting on attacks on education; investigate and prosecute possible war crimes involving schools; and quickly restore access to education when schools are attacked.

Secretary Leonor Magtolis Briones has designated the Undersecretary for Administration to represent the department and the country to the international conference, and as such, the Undersecretary is expected to report the national situationer of schools in armed conflict areas.

All concerned are hereby required to submit, on or before March 24, 2017, the list of schools in their areas of responsibilities that have been involved in armed conflict situations from 2013 to 2017. The involvement includes either being within 500m to 1 kilometer distance from the presence of armed combatants at any given time, having classes suspended as a consequence of nearby


armed conflict, or having school administrators, teachers, students and/or service providers prevented from going to the schools and/or performing their school-related works.


The reports should include the names of schools, addresses, number of students affected, incidences, number of days or period, and involved armed combatants.

For speedy reporting to beat the deadline, the reports should be submitted via email at usec.admin@deped.gov.ph on or before 5pm of March 24, 2017.

Schools which will not be submitting reports will be listed as schools free from disturbances of armed conflict since 2013.
