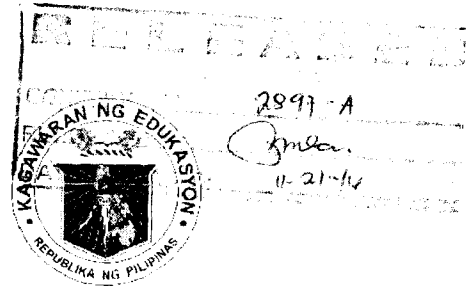

This is to announce to the field the Approval of the creation of additional school districts in the Schools Division of Negros Oriental based on the Approved DepEd RatPlan categorizing the division as Large Schools Division allocated with thirty-three (33) regular plantilla items for Public Schools District Supervisor.
2. Attached herewith is a copy of the Approved School Districts dated November 17, 2016 for the information and guidance of all concerned
3. School District Temporarily Operating as sub-district/s will now obtain regular school district status.
4. Existing Lone Districts that have not yet started establishing sister district shall start the re-districted operation by June, 2017 to give ample time for the preparation to commence at this early stage. PSDSs/DICs of these districts shall coordinate with the Office of ASDS Dexter Y. Aguilar for the final listing and inventory of schools in the districts, finalization of district map, as well as the proposed location of the Central Schools. Assignment of District In Charge shall be made by the SDS. Kindly inform the Local Government Officials regarding the matter.
5. Schools District shall be numbered numerically with the Capital City as preferred reference.
6. Immediate and wide dissemination of the content of this Memorandum is desired.
