Pursuant to DepEd Order No. 53, s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers, teachers may be granted a two (2) day service credits for their participation in each of these activities, provided that they have completed the required number of days and must have obtained prior authority to attend the workshop, duly approved by their respective Schools Heads and/or Schools Division Superintendents.
