

TWO-DAY TRAINING ORIENTATION ON THE USE OF THE PRINCIPALS' TEST ONLINE APPLICATION SYSTEM

To: Schools Division Superintendents
 Heads, Public Elementary and Secondary Schools

1. This Office, through the Quality Assurance Division, shall conduct the ~~3~~ 2-day Training Orientation on the Use of the Principals' Test Online Application System on October 26-27, 2017 at Ecotech Center, Lahug, Cebu City.
2. Each Schools Division, including those from Negros Oriental Province, is expected to send two participants to this training orientation, who are the following:
 - 2.1 Human Resource Management Officer or a representative from the Personnel Section
 - 2.2 Division IT Officer or another IT staff as representative
3. The participants from the Regional Office are Ms. Merden L. Bryant (Regional Principals' Test Focal Person), Ms. Johnmyline P. Jagdon (Regional IT Officer), and Dr. Brazil B. Sanchez (Regional Human Resource Management Officer). They will be assisted by one Central Office Staff.
4. The aim of this activity is to train and orient the participants on how to use the Principals' Test Online Application System, in preparation for the 2017 Principals' Test, which is scheduled to be administered in December 2017.
