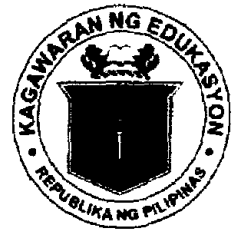

**OBSERVANCE OF THE SIXTH JUVENILE JUSTICE AND WELFARE
CONSCIOUSNESS WEEK**

1. The Department of Education (DepEd) supports the Juvenile Justice and Welfare Council (JJWC) in the observance of the **Sixth Juvenile Justice and Welfare Consciousness Week** from November 19 to 25, 2017.

2. The theme of this year's celebration is *Mapagkalingang Hustisya: Ugaliin at Pagtibayin!* to highlight the concept of Restorative Justice. This refers to the principle of resolving conflicts with the maximum involvement of the offender, offended, and the community to achieve the following:

- a. Reparation for the victim;
- b. Reconciliation of the offender, offended, and the community;
- c. Reassurance to the offender that he/she can be reintegrated into society; and
- d. Enhancement of public safety by activating the offender, the victim, and the community in prevention strategies.


3. In view thereof, all schools and schools division offices are hereby encouraged to participate in the week-long observance through the following:

- b. Conduct of fora or seminars on Restorative Justice Approaches and Strategies;
