For the past 15 years, PSF was blessed to be hailed as one of the Ten Accomplished Youth Organizations of the Philippines by the TAYO Awards Foundation and Dangal ng Bansa by the Komisyon sa Wikang Filipino. It was also recognized numerous times by the Aliw Awards and by the Broadway World Awards for mounting multi-award winning musical productions. # **OBRA NI JUAN**

#### Sa Panulat at Direksiyon ni Vincent M. Tañada

Isang dulang musikal na naglalaman ng linya o diyalogo na pasalita at pakanta. Ang ilan sa mga awitin ay sasamahan din ng sayaw. Sasaliwan naman ng orkestra na tugtog sa mismong pagtatanghal. Tatakbo ang dula ng dalawang oras na maaaring lagyan ng pagitan pagkatapos ng unang yugto. Nagtataglay ito ng tatlong yugto at may higit sa tatlumpung tagpo. Gagampanan ito ng higit sa apatnapung mandudula.

Umiikot ang istorya sa buhay at mga obra ni Juan Luna (October 23, 1857 – December 7, 1899), isang pintor, iskultor at rebolusyunaryong Filipino ng mga huling taon ng ika-labing siyam sa siglo. Isa siya sa maituturing na naunang Filipinong alagad ng sining ng bansa. Ang pagwawagi niya ng gintong medalya sa 1884 Exposición Nacional de Bellas Artes sa Madrid ang naging natatanging sanhi ng isang pagdiriwang at pagtitipon ng mga kasaping Ilustrado ng Propaganda at nagbigay daan sa Reboslusyon laban sa mga Kastila.

Taong 1883 sinimulan ni Luna ang pagpinta na hinilang ng Ayuntamiento. Noong Mayo 1884, inangkat ang malaking kambas na gagamitin sa pagpinta ng Spolarium sa Madrid. At noong Hunyo 25, 1884 pagkatapos ng pagwawagi ni Luna ng gintong medalya para sa eksibisyon, nagtipon ang mga Filipinong hinirang at nagbigay ng talumpati si Dr. Jose Rizal upang papurihan ang angking galing ni Luna.

Noong Disyembre 8, 1886, nagpakasal si Luna kay Maria de la Paz Pardo de Tavera. Ang mag-asawa ay tumulak sa Venice at Roma bago tuluyang nanirahan sa Paris. Minahal ni Luna ang kanyang asawa at ang sobrang pagmamahal ang nagbunsod sa kanya ng labis na pagseselos at pagdududa. Pinagdudahan ni Luna na nagtataksil ang kanyang asawa at karelasyon ang isang Monsieur Dussaq. At noong Setyembre 22, 1892, dumating ang sukdulan ng kanyang pagseselos at napatay niya ang kanyang asawa at biyenan na babae, at nasugatan ang bayaw na si Felix. Napawalang sala naman si Luna dahil sa depensang krimen de pasion, isang pansamantalang pagkabaliw dahil sa matinding pagseselos.

Sa kanyang mga huling taon, noong taong 1894, bumalik si Luna sa Pilipinas at nataon sa Sigaw ng Pugad Lawin sa Balintawak. At noong Setyembre 1896, inaresto si Juan at ang kanyang kapatid na si Antonio ng mga gwardia sibil na Kastila dahil sa kanilang partisipasyon sa Katipunan. Habang nakakulong, nakagawa pa si Luna ng isang obra na ibinigay niya sa isang paring bumisita sa kanya. Binigyan si Luna ng pardon ng hukuman kaya't muling umalis ng bansa at tumulak sa Espanya. Sa kanyang pagbabalik sa Maynila dahil sa pagpatay sa kanyang kapatid na si Antonio noong Disyembre 1899, lubos niyang dinamdam ang lahat ng naganap at noong Disyembre 7, 1899 siya ay binawian ng buhay dahil sa isang atake sa puso.

Ang dulang ito ay isang eksperimental at malalim na paghimay at pagsanib ng sining-biswal at pagtatanghal. Sisilipin ang tunay na kahulugan ng kanyang mga obra tulad ng Spolarium at Parisian Life at tila ba mabubuhay sa entablado ang mga likhang ito sa pamamagitan ng teatro. Ito ay isang pambihirang pagkakataon na magsanib pwersa ang napakaraming uri ng sining para sa isang natatanging pagtatanghal.

Bonifacio, Isang Sarswela	The 2012 KBP Golden Dove Awardee is a musical presentation about the life of Andres Bonifacio.

- teach the students about the value of life, freedom, human rights, and democracy;
- impart to their audience the value of heroism and the struggles of the nation during Martial Law;
- 3. teach the importance of family, friendship, and love of country;
- 4. promote Filipino values, culture, and the arts; and
- 5. teach mastery of the Filipino Language and Literature through the lines and dialogues using the vernacular of the present times.

The learners and teachers from both public and private secondary schools are invited to watch the plays and musicals.

Participation of both public and private schools shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 entitled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith. This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546, An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges, and Universities (Ganzon Law).
