The Bureau of Learning Delivery through the Student Inclusion Division (BLD-SID) will conduct the **Orientation-Seminar for Alternative Learning System (ALS) Coordinators/Facilitators on Handling Children in Conflict with the Law** on the following dates and venues: **February 21-24, 2017 at Dipolog City for Batch 1-Visayas and Mindanao Cluster** and on **March 6-9, 2017 at Baguio City for Batch 2-Luzon Cluster**, exclusive of travel time.

The Orientation-Seminar aims to provide the participants with the information on psycho-social intervention including resources and support in handling students-at-risk (bullying, abuse, discrimination, exploitation, violence) and in-conflict with the law.

The participants are advised to purchase the most reasonable mode of transportation, and that reimbursement shall be made only at the venue upon submission of the approved travel authority, original bus or plane tickets and other necessary document.
