



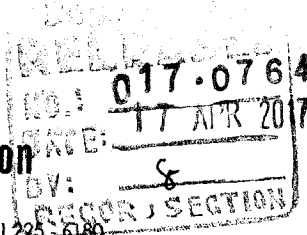

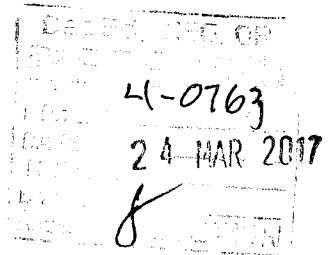


Dear *Dr. Jimenez*,
