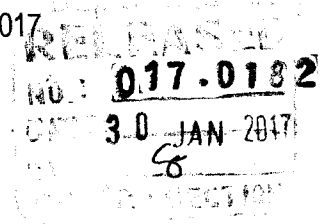

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will conduct the **National Conference on the Standardized Administration of Accreditation and Equivalency Test (A&E), National Achievement Test for Grades 6 and 10 (NATG6 & 10), and the Early Language Literacy and Numeracy Assessment (ELLNA) for the School Year (SY) 2016-2017** by cluster on the following dates with respective venues:

2. The following topics shall be discussed in the said Conference:
 - a. Standard Procedures on the Conduct or Administration of the Tests;
 - b. Security of Test Materials, Delivery and Retrieval Scheme;
 - c. Allocation of Test Materials; and
 - d. Financial Matters Relative to Test Administration.
3. Regional testing coordinators (RTCs) from all the regions, one division testing coordinator (DTC) from each schools division, and one private school supervisor (PPS) from each schools division that has at least 20 private schools are authorized to attend on the specified dates and venues.
4. The DTCs are directed to bring the actual enrolment of A&E registrants, Grades 4, 6 and 10 learners for SY 2016-2017, both public and private elementary and secondary schools for allocation of test materials. The enrolment data to be submitted should be based on **August 21, 2016** for both public and private schools in soft and hard copies, in Excel as shown in the format below:

5. The participants must attend only on the date and at the venue where their respective regions are clustered. Conference proper will start at exactly 8:00 a.m. Participants can be accommodated on the evening before the scheduled conference.
6. Travel expenses and allowable expenses shall be charged to BEA Funds, subject to the usual accounting and auditing rules and regulations.
