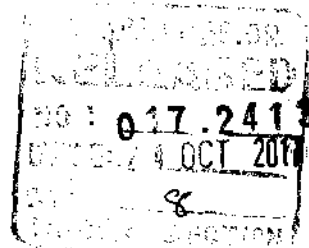

In accordance with Executive Order No. 773, entitled Further Reorganizing the Peace and Order Council, the National Peace and Order Council (NPOC) Interim Secretariat was tasked to coordinate and monitor the integrated peace and order efforts and affirmative action of the government.

One of the major activities determined to contribute to the effective response to peace and order problems is the formulation of Peace and Order and Public Safety Plan (POPS Plan), as contained in DILG Memorandum Circular No. 2015-128. It is a 3-year term-based plan, which covers activities that address peace and order and public safety issues of the LGU.

Accordingly, a Peace and Order and Public Safety Plan Monitoring System was established by the DILG. It is an information system that monitors POPS Plan implementation in each LGU.

Executive Order No. 18-17

**AN ORDER CREATING THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC)-
TECHNICAL WORKING GROUP (TWG)**

WHEREAS, DILG Memorandum Circular No. 2015-130 dated November 3, 2015 was issued to further strengthen the POCs pursuant to the Peace and Development Agenda;

WHEREAS, as provided in the above stated issuance, one of the roles and functions of the Provincial Peace and Order Council is to create a Technical Working Group (TWG) for the purpose of Peace and Order and Public Safety (POPS) Planning, following the guidelines prescribed by the DILG on the tools and processes on POPS Planning;

WHEREAS, The Peace and Order and Public Safety Plan (POPS Plan), as contained in DILG Memorandum Circular No. 2015-128 is a 3-year term-based plan, which covers activities addressing peace and order and public safety issues of the LGU:

WHEREAS, the Bureau of Local Government Supervision (BLGS) of the Department of the Interior and Local Government (DILG) has developed a POPS Planning Guidebook to assist the LGUs in the formulation of their POPS Plans;

WHEREAS, the DILG-BLGS as the Interim NPOC Secretariat conceptualized and developed an on-line database and monitoring system, the Peace and Order and Public Safety Plan Policy Compliance Monitoring System (POPSP PCMS);

NOW, THEREFORE, I, Roel R. Degamo, Governor of the Province of Negros Oriental, by virtue of the powers vested in me by law, do hereby order and direct the following:

Section 1. Creation of the Provincial Peace and Order Council (PPOC)-Technical Working Group (TWG). – The PPOC-TWG shall be created and constituted as follows:

Section 2. Tasks and Responsibilities. – The PPOC-TWG shall perform the following:

- a. Prepare documents that could serve as reference for the profiling of the strategic direction and peace and order and public safety issues in the locality;
- b. Conduct data gathering and stakeholder consultations as needed and analyze data gathered;
- c. Coordinate with communities or barangays for data-gathering and action planning for implementation of POPS Plan;
- d. Present data to the POC for prioritization of issues and development strategies;
- e. Participate in the POPS planning process, draft parts of the POPS Plan as assigned, and participate in the writeshop that would finalize the POPS Plan;
- f. In coordination with the Governor, convene the POC and present the Plan for discussion, approval, and appropriate action;
- g. Take part in the submission and adoption of the POPS Plan;
- h. Coordinate with internal and external stakeholders for effective communication and monitoring as laid out in the POPS Plan;
- i. Ensure inclusion of key programs or strategies (MC 2015-128, Annex 3) such as Community and Service-Oriented Policing (CSOP) and conflict-sensitivity, if deemed appropriate, in the POPS Plan;
- j. Establish and manage a monitoring and evaluation system and regularly submit Accomplishment Reports (ARs). Coordinate adjustments to the POPS Plan as needed.

Section 3. Effectivity. – This Order shall take effect immediately.
